☐ **This Document Certifies** that the puppy has received appropriate care while under our supervision. The puppy has been properly dewormed, is current on all age-appropriate vaccinations, and is in good health at the time of transfer to the new owner. Once a deposit has been processed and Go Home Day decided. The puppy will be scheduled to see my licensed veterinarian (Alpha Vet Animal Clinic, this may take up to 3 - 5 business days). Your puppy will have a full head to tail exam (paid for by the breeder) before going to its forever home. This is to ensure you have a healthy happy puppy.

☐ **30 DAY - Healthy Puppy Guarantee:** You must have your puppy examined by a licensed veterinarian within 5 days of going home, at buyer expense, to confirm its health. If diagnosed with a life-threatening condition not stated in the seller's Vet Health Report, contact the breeder immediately. (SEE RETURN POLICY)

☐ **3 YEAR - Genetic Health Guarantee** (AKC puppies only): If your puppy develops a life-altering, breed-specific genetic condition (confirmed by genetic panel) before their 3rd birthday, contact the breeder immediately. (SEE RETURN POLICY)

☐ **THE BUYER / New Owner Guarantee:** You the buyer must vaccinate, deworm, provide flea and tick prevention, maintain a balanced diet, ensure daily exercise, and attend to nails, ears, eyes, teeth, hair, and weight. All according to your licensed veterinarian. Annual vet exams are required. Neuter or spay by their 1st birthday. Failure to follow veterinary protocols voids all health contracts.

☐ **We've partnered with Trupanion.com (Pet Insurance)** to include **30 days of FREE complimentary medical coverage for pets** as part of your puppy's transition from our care to yours. While activation is entirely optional, ASK YOUR BREEDER FOR MORE INFORMATION.

☐ **Register your puppy's micro-chip** with Global Pet Security  . A Micro-chip must be REGISTERED with the new Owners Name to link puppy to its New Owner. (Note:) After the puppy comes home. Simply Scan the QR Code on the pet I.D. tag to register.

RETURN POLICY = Contact seller immediately!! (**NOTE: ALWAYS REFER TO THE INVOICE NUMBER WHEN CONTACTING SELLER ABOUT PUPPY**) You must submit a full report of the diagnosis from a Licensed Veterinarian, including their signed statement and contact details, confirming the puppy was not abused or neglected and is no longer suitable as a companion pet. *If the issue is life-altering, a second vet—chosen by the breeder—must also provide a full report. If diagnosed, you have two options: (1) The breeder agrees to pay the vet bill "directly related to the puppy's issue", up to the purchase price or (2) return the puppy to the breeder for another puppy of the same color, breed, and size from the next available litter, (or a puppy agreed upon by both breeder and buyer).

- a. ***A copy of the "Vet Health Report" of your first Vet visit must be send to seller via email, or all guarantees are void***
- b. ***Any health condition that is common or easily correctable, is not covered and deposit non-refundable**
- c. ***At no point will seller pay more than purchase price of puppy.**
- d. ***Breeder is not responsible for puppy's change of color and temperament as they mature.**
- e. ***Breeder is not responsible for any OFA's, allergies or damages caused by your puppy.**
- f. ***Breeder is not responsible for any cost related to genetic testing, veterinarians, or transportation of puppy after final sale.**
- g. ***Puppy sells with limited registration.**
- h. ***Health Contract is non-transferable from original owner, and must be saved and presented in paper or PFD to be valid!!**
- i. ***Any legal fees incurred will be the responsibility of the buyer.**

WE ARE REQUIRED TO COLLECT 7% SALES TAX ON ALL PUPPIES SOLD IN INDIANA

A non-refundable deposit of \$300 is required to reserve or hold your puppy. This deposit will be applied toward the total purchase price. The remaining balance must be paid in full prior to the puppy's departure from the breeder's residence.
